

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE FORT
APACHE INDIAN RESERVATION

BE IT RESOLVED by the Council of the White Mountain Apache Tribe in regular session this date, March 9, 1942, that:

The Maverick Timber Unit be advertised for sale to the highest bidder, provided that:

1. The portion of "General Timber Sales Regulations" concerning brush disposal, and in particular that portion thereof which requires cutting, piling and burning of all limbs four inches and under, be strictly enforced by the Forest Officer in charge. (Such action should reduce, insofar as possible, the difficulty of handling cattle in recently cut-over areas.)
2. The Unit be logged on a sustained yield basis, with the permissible annual or periodic cut in accordance with the Mount Thomas Working Circle Management Plan which is now being prepared by the Regional Forestry Office in Phoenix, Arizona.
3. Scenic and protection strips of timber be left on each side of all major truck trails, along all streams and around the edges of certain areas such as Tonto and Pacheta cienegas (such strips to be not less than 100 Ft. wide and wider where necessary). And that merchantable timber within the adjoining roadless area be not cut. Logging and truck roads shall not be not out. Logging and truck roads shall not be constructed across Reservation Ranch Cienega, which lies north of Reservation Ranch and adjacent to the east Reservation boundary and Pacheta cienega.
4. Any or all reservation truck trails used by the Operator for log hauling or other transportation purposes be maintained by the Operator.
5. Payment in full shall be made by the Operator to any Indian or permittee whose stock is killed or crippled as a result of logging or transportation operations of the Operator. Prices to be determined by a committee of the Tribal Council and stockman in the district concerned.
6. All range or forest improvements, fences, cattle guards, telephone lines, etc., which are damaged as a result of logging or transportation activities shall be repaired by the Operator.

7. Ponderosa Pine on the Unit shall not be advertised at less than \$3.00 per M. and other species at not less than \$1.50 per M.

The foregoing resolution was made this 9th day of March, 1942, duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Section 1 (c), Article VI of the Constitution and By-laws of the Tribe, ratified by the Tribe on August 15, 1938, and approved by the Secretary of the Interior on August 26, 1938, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
