WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council intends to lease certain areas of ground to the Traders, and

WHEREAS, for many years they have paid no rental for the use of said premises.

BE IT RESOLVED that the following rental fees be established for the respective Traders effective September 1, 1962.

The foregoing resolution was on August 2, 1962, duly adopted by a vote of 8 for and 0 against by the Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Sections 1 (b) and (i) of the amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
