

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the firm of Haver, Nunn and Jensen, the architects for EDA o8-1-00660 (Sunrise Park) in a letter dated December 12, 1969 made recommendations for award of contracts, and

WHEREAS, these recommendations are the most practical means of obtaining maximum benefits from the EDA grant and appear to be based on sound judgement.

BE IT RESOLVED that the following recommendations for award of contracts, as taken from the Architects' letter of December 12, 1969, are hereby approved:

1. Architectural contract to Hunt Building Mart, Inc.:

2. Roads contract to Hunt Building Marts, Inc.

b. Alt. 2B, Building D Roads	(10,457.25)
c. Alt. 4, Parking Lot A	(3,131.25)
d. Alt. 5, Parking Lot E	<u>(7,809.75)</u>
Amount of Roads Contract	\$ 99,726.25

3. Utilities Contract to Packer Construction Company.


Base bid in the amount of	\$138,100.77
Less the following alternate:
