

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Ordinance requires that the Election Board Personnel be appointed by the Tribal Council at least ten (10) days prior to the Election, and

WHEREAS, the Tribal Council deliberated for some hours to find suitable members for said Board.

BE IT RESOLVED that the attached document denominates the Election Boards of the White Mountain Apache Tribe designating the respective polling places of the Election Boards is hereby approved.

The foregoing resolution was on March 2, 1972 duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and by-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
