

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the White Mountain Apache Tribe owns and operates the Sunrise Ski Area, and

WHEREAS, the Board of Directors, Sunrise Ski Area, has submitted and recommends approval by the Tribal Council of a general and operating budget for the Sunrise Ski Area for the Fiscal Year May 1, 1972 through April 30, 1973 and said budget has been prepared and recommended in accordance with the Plan of Operation for the enterprise, and

WHEREAS, the Plan of Operation of the Sunrise Ski Area was approved October 15, 1971.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the budget for general operating expense in the amount of \$149,831.00 and Capital Expenditures amounting to \$42,329.00 is hereby approved for the operation of the Sunrise Ski Area for the Fiscal Year beginning May 1, 1972 and ending April 30, 1973.

The foregoing Resolution was on September 18, 1972 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958 pursuant to Section 16 of the Act of June 18, 1934 (48. Stat. 984).
