


RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION


WHEREAS, the General Livestock Manager presented the White Mountain Apache Cattle Association and Individual Cattle Owners Loan Agreement-Purpose and Policy, and

WHEREAS, copy of said Purpose and Policy is attached hereto.

BE IT RESOLVED by the Council of the White Mountain Apache Tribe that the White Mountain Apache Cattle Association and Individual Loan Agreement-Purpose and Policy attached hereto marked Exhibit "A" and by reference made a part of this resolution by and it is hereby approved.

The foregoing resolution was on February 7, 1973 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
