

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Jeyfus J. Classay, Marjorie Quade, Shirleen Nash, Linda Prins, Genevieve Hopper, Catherine Davenport, Delphine Altaha, Bert Hinton, Wallace Quintero, Lorinda Tortice, Nina Quesada, Elena Baha, and Margaret Bones have applied for a loan from the Farmers Home Administration to construct a home, and

WHEREAS, the Farmers Home Administration requires a residential lease in the names of Jeyfus J. Classay, Marjorie Quade, Shirleen Nash, Linda Prins, Genevieve Hopper, Catherine Davenport, Delphine Altaha, Bert Hinton, Wallace Quintero, Lorinda Tortice, Nina Quesada, Elena Baha and Margaret Bones, the proposed borrowers, and

WHEREAS, by enactment of Ordinance No. 91, the Tribal Council on May 3, 1972 approved the lease form acceptable to the Farmers Home Administration, and

WHEREAS, the Tribal Council has no objection to the use of this land by the above-named individuals, and

WHEREAS, the Tribal Council has no objection to the lessors mortgaging the leasehold improvements to the Farmers Home Administration.

BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe does hereby grant and approve a residential lease to Jeyfus J. Classay, Marjorie Quade, Shirleen Nash, Linda Prins, Genevieve Hopper, Catherine Davenport, Delphine Altaha, Bert Hinton, Wallace Quintero, Lorinda Tortice, Nina Quesada, Elena Baha, and Margaret Bones as required by the Farmers Home Administration for a period of twenty-five (25) years automatically renewable to an individual term of twenty-five (25) years.

BE IT FURTHER RESOLVED that the Chairman of the White Mountain Apache Tribe is hereby authorized to approve the mortgaging of the leasehold improvements as required by the Farmers Home Administration.

BE IT FURTHER RESOLVED that the Tribal Chairman is authorized to execute said lease in accordance with Tribal Ordinance No. 91, the effective date the lease shall be the date of loan closing by the Farmers Home Administration.

BE IT FURTHER RESOLVED that should an assignment have been made on the land which is hereby leased to Jeyfus J. Classay, Marjorie Quade, Shirleen Nash, Linda Prins, Genevieve Hopper, Catherine Davenport, Delphine Altaha, Bert Hinton, Wallace Quintero, Lorinda Tortice, Nina Quesada, Elena Baha, and Margaret Bones, the lease shall automatically cancel the assignment.

BE IT FURTHER RESOLVED that should the loan not be approved within 180 days from the date hereof, the lease and approval of right to mortgage the leasehold improvements shall thereby automatically terminate.

The foregoing resolution was on February 7, 1973 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (b) and (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
