## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Marina (Patterson) Allen has applied for a Tribal loan to remodel their house, and Bruce and Benrita (Burnette) Declay have applied for a tribal loan to construct a house, and;
- WHEREAS, Marina (Patterson) Allen, Bruce and Benrita (Burnette) Declay require a homesite lease, and;
- WHEREAS, a homesite lease is required by Section 23 (c) II of the Declaration of Policies and Plan of Operation approved September 18, 1962, and;
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has no objection of the leasee mortgaging the leasehold improvement to the White Mountain Apache Tribe Revolving Credit Program.
- BE IT RESOLVED that the members of the Tribal Council of the White Mountain Apache Tribe do hereby approve and grant a homesite lease to Marina (Patterson) Allen, Bruce and Benrita (Burnette) Declay for a period of twenty-five (25) years with an option for an additional term of twenty-five (25) years at the rate of \$1.00 for twenty-five (25) years, payable in advance on the effective date of the lease.
- BE IT FURTHER RESOLVED that the Tribal Council Chairman shall execute said lease for and on behalf of the White Mountain Apache Tribe in accordance with Tribal Ordinance No. 44; the effective date of the commencement of said lease being the date of the approval of the loan by the Secretary of the Interior or his designated representative.
- BE IT FURTHER RESOLVED that should an assignment have been made on the lot which is hereby leased, the lease shall automatically cancel the assignment.
- BE IT FURTHER RESOLVED that the Tribal Chairman shall approve the leasehold mortgage mortgaging the improvements to the White Mountain Apache Tribe Revolving Credit Program.
- BE IT FURTHER RESOLVED that should the loan not be approved within one hundred-eighty (180) days from the date hereof, the lease and approval of right to mortgage the leasehold improvements shall thereby automatically terminate.

The foregoing resolution was on August 3, 1977, duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat. 984).
