FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council has considered the recommendation of the Land Board for assignment of irrigated farmland, dry farmland, and homesites, and;

WHEREAS, the following list of assignments have been made according to the Tribal Land Code.

BE IT RESOLVED by the Council of the White Mountain Apache Tribe that the Chairman and Superintendent make the following assignments:

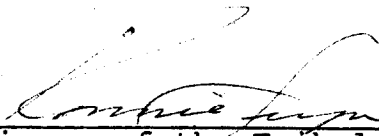

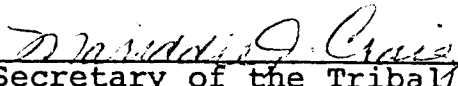
