RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is informed that a "Petition for Rule Making to Amend the Radio and Television Table of Assignments to Assure Native American Indians of Adequate Access to and Control of Broadcast Facilities", Docket No. RM-3245, is presently pending before the Federal Communications Commission, Washington, D. C., and
- WHEREAS, the Tribal Council has considered the contents and purpose of said petition and finds that it serves the interests of the Indian people, in broadcasting field, and
- WHEREAS, this matter directly affects the White Mountain Apache Tribe which represents a large percentage of the Indian population and is located on the fifth largest reservation in the United States, and
- WHEREAS, the Tribal Council feels that the local broadcast facilities at the present time fail to meet the needs of the reservation, and
- WHEREAS, the Tribal Council believes that the successful outcome of this petition will better ensure the tribe its opportunity to secure ownership of its own broadcasting facility.
- BE IT RESCLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby strongly and fully endorses the "Petition for Rule Making to Amend the Radio and Television Table of Assignments to Assure Native American Indians of Adequate Access to and Control of Broadcast Facilities", Docket No. RM-3245, pending before the Federal Communications Commission.
- BE IT FURTHER RESOLVED that the Tribal Chairman is hereby authorized and directed to advise all necessary parties of this action.

The foregoing resolution was on February 07, 1979 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
