RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is informed and advised that some Indian Health Service personnel on the Fort Apache Indian Reservation are advising or encouraging Apache mothers or mothers-to-be, to relinquish their parental rights over their children; and
- WHEREAS, the exercise of any influence by any person or persons in the decision of an Apache mother to retain or relinquish her parental rights, or custody, of her minor child, is deemed an act against the Tribe, when done outside of the confines of tribal law, tribal jurisdiction, and tribally authorized or approved social welfare programs dealing with such matters; and
- WHEREAS, the Tribal Council is concerned and responsible for the best health and welfare of all White Mountain Apaches, including the circumstances of any and all child placements, guardianships and adoptions; and
- WHEREAS, the Congress of the United States has recently enacted P.L. 95-608, the INDIAN CHILD WELFARE ACT of 1978, which recognized such tribal interests by providing for the exclusive jurisdiction of Indian Tribes over any child custody matter and thereby declaring that "it is the policy of this Nation to protect the best interests of Indian children and to promote the stability and security of Indian Tribes and families..."; and
- WHEREAS, the Tribal Council expects and demands that all Indian Health Service personnel on the Reservation support these interests and responsibilities of the Tribe, rather than defeat them.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache
 Tribe that it hereby re-affirms its policies and laws
 that all actual or potential matters involving the parental
 rights over, or the placement, guardianship or adoption of
 White Mountain Apache children be referred to the proper
 tribal officials and agencies and that it directs that no
 action, advice or encouragement be undertaken by any person
 in contact with such child matters to deal with said
 matters outside of these policies and laws of the White
 Mountain Apache Tribe.

BE IT FURTHER RESOLVED that the Tribal Chairman is hereby directed to give notice of the directives herein contained to any affected, interested or otherwise appropriate agencies on the Reservation.

The foregoing resolution was on March 13, 1979, duly adopted by a voted of <u>eight</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934, (48 Stat. 984).
