

RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been requested by Milfred Cosen, a tribal member, for an educational leave of absence from his position with the Tribal Planning Office for a period of sixteen (16) months in order to obtain a Masters Degree in Business Administration from the Arizona State University, and

WHEREAS, Milfred Cosen has entered into an Education Leave Agreement with the White Mountain Apache Tribe which is attached hereto and incorporated by reference, and

WHEREAS, the Tribal Council believes it to be in the best interests of the Tribe to grant said Education Leave Agreement according to the provisions of the Education Leave Agreement between Mildred Cosen and the White Mountain Apache Tribe.

BE IT RESOLVED that Milfred Cosen is hereby granted his request for an Educational Leave of absence pursuant to the provisions set forth in the attached Education Leave Agreement.


The foregoing resolution was on January 07, 1981 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
