## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the citizens of the town of Carrizo are in dire need of full-time police protection, and
- WHEREAS, these people in recognizing this need and the advantages, and benefits which would fall to them and their town if such protection were available, have sought the assistance of the White Mountain Apache Tribal Police and the Law and Order Committee, and
- WHEREAS, approximately sixty (60) families of this area have met with Police Chief, Reno Johnson, and discussed their urgent need, and
- WHEREAS, it is apparent to the Police Department that the part-time protection afforded the citizens of Carrizo by the stationing of one officer, Alvin Truax, in their area is inadequate, and
- WHEREAS, in order to provide the full-time service needed by these people, it is necessary that the Tribal Police Department reopen their previously abandoned Carrizo Sub-Station, and
- WHEREAS, said Sub-Station has fallen upon almost total disrepair and is in immediate need of new windows, flooring, plumbing and other repairs before it can be adequately used for the requested purposes, and
- WHEREAS, the White Mountain Apache Development Enterprise has submitted a proposal for this repair in the amount of \$8,470.00 and said proposal is attached hereto, and
- WHEREAS, the estimated completed costs of this project would be around \$10,000.00, and
- WHEREAS, neither the town of Carrizo nor the White Mountain Apache Tribal Police Department is adequately budgeted for these amounts, and
- WHEREAS, it is the over-riding opinion of the Law and Order Committee that these repairs must be made because the community of Carrizo desperately needs the services and security of a full-time Police force, and
- WHEREAS, these funds may be available under the Tribal Revenue Sharing Account.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe it hereby approves the necessary remodelling and repairs from Revenue Sharing funds for a Police Sub-Station at Carrizo.
