RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has been presented a proposal for approval by the Cibecue Parents Advisory Board for the establishment of a Day Care Center in Cibecue; and
- WHEREAS, the Cibecue Parents Advisory Board has demonstrated that there is a great need for a Day Care Center for the Cibecue Community so that working mothers can have a reliable and safe place for their children, that the Day Care Center would better prepare their children for school especially those who cannot qualify for Head Start, that the Day Care Center would make available much needed jobs in Cibecue; and
- WHEREAS, the Cibecue Parents Advisory Board has raised funds through community sponsored activities and have demonstrated their Board commitment to donate their time and efforts and have demonstrated a sense of community working and planning together to achieve their goals; and
- WHEREAS, the Tribal Council admires and respects the demonstrated volunteer efforts by the Cibecue Parent Advisory Board and therefore, agrees to support their efforts in every way possible; and
- WHEREAS, the Cibecue Parent Advisory Board requests funding to operate a Day Care Center in Cibecue and the Tribal Council having take such request under consideration and after some discussion recommends to the Parent Board that they contact their Board Members and the two Council Members and arrange for disbursement and allocation of approximately \$43,000.00 from the Land Claims account for the purpose of establishing and operating their proposed Day Care Center and further directs the Cibecue Parents actively seek Revenue Sharing Funds for the same purpose.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that they support the effort of the Cibecue Parents Advisory Board to establish a Day Care Center in Cibecue as they proposed before the Tribal Council.
- BE IT FURTHER RESOLVED that the Cibecue Parent Advisory Board is directed to meet with their respective Councilmen representatives and arrange for the disbursement of the necessary funds from the Community Land Claims account for purposes of operating their proposed Day Care Center.

- BE IT FURTHER RESOLVED that the Cibecue Parent Advisory Board is further directed to seek Revenue Sharing Funds which may be available to operate the Day Care Center in Cibecue.
- BE IT FURTHER RESOLVED that the Tribal Council acknowledges the following officers for the Cibecue Day Center and their Advisors for the fine work they have accomplished in presenting their proposal to the Tribal Council:
