RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, on June 2, 1981, the Cibecue Day Care Center Parent Advisory Board presented to the Tribal Council of the White Mountain Apache Tribe a proposal to establish a Day Care Center in Cibecue; and
- WHEREAS, as a result of the proposal, the Tribal Council unanimously adopted Resolution No. 81-154 authorizing the Parent Advisory Board to establish concrete plans to set up a Day Care Center through acquiring monies from the Tribal Revenue Sharing Funds and/or the Land Claims Apache Youth Recreation Office; and
- WHEREAS, per the instructions of Tribal Resolution No. 81-154, the Cibecue Day Care Center Parent Advisory Board met with their respective Council Member and discussed operational funds and building funds as set forth in the attached proposed budget; and
- WHEREAS, it was determined by those present that operational funds for the Day Care Center be approved by the Tribal Council in the amount of \$61,590.00 from Tribal Revenue Sharing Funds.
- BE IT RESOLVED by the Tribal Council that it hereby accepts the recommendation and request of the Cibecue Day Care Center and approves the sum of \$61,590.00 to be used for operational funds on a one time basis from the Revenue Sharing Funds as set forth in the proposed budget attached hereto.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it encourages the Parent Advisory Board of Cibecue to seek other funds for future operational purposes.
- BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it supports the efforts of the Cibecue Day Care Center Parent Advisory Board.

The foregoing resolution was on <u>July 1, 1981</u>, duly adopted by a vote of <u>eight</u> for and <u>zero</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested it it by Article V, Section 1 (i) of the Amended Constitution and By-Laws

of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
