FORT APACHE INDIAN RESERVATION


WHEREAS, the Tribal Council has been requested by Kenneth Hart, General Manager of the Apache Enterprise for permission to establish a Good Year Tire dealership for purposes of selling tires to the Tribal Enterprises within the boundaries of the reservation on a Federal Open Market, and


WHEREAS, Kenneth Hart has included with his request, example of the savings obtained by Apache Enterprise or other Tribal Enterprises who wish to purchase tires at the Federal Open Market price, a copy of which is attached hereto, and

WHEREAS, the Tribal Council concludes that the establishment of such dealership would be in the best interests of the Tribal Government and its Enterprises in terms of substantial monetary savings to the Tribal Enterprises for the purchase of tires for motor vehicles.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that permission is hereby granted to Kenneth Hart, Manager of Apache Enterprise, to establish a Good Year dealership for purposes of selling tires to Tribal Enterprises on a Federal Open Market Program.

The foregoing resolution was on February 03, 1982 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

## APACHE ENTERPRISE TIRE

### 1) Establish a Goodyear Dealership:

We then can sell tires to the Tribal Enterprises on a Federal Open Market.

#### EXAMPLE:

- a) Apache Enterprise buys a 700 X 15 6 ply Highway Tire. We pay \$47.74 for this tire.

Recreation wants to purchase this tire. They are a Tribal Enterprise, and therefore are eligible for the Federal Open Market Program.

We will fill out the proper forms supplied by Goodyear and submit them to Goodyear.

Goodyear will bill Recreation Enterprise for this tire at the Federal Open Market price of \$36.80.

Apache Enterprise Tire will receive credit for the \$47.74 they originally paid for the tire, plus 5% for handling.
