

RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION

WHEREAS, the Chief Judge of the White Mountain Apache Tribal Court has authority to promulgate rules to govern Tribal Court Proceedings subject to the approval of the Tribal Council pursuant to Part VI, Section 16.1 A and B of the Tribal Code, and

WHEREAS, the Chief Judge has promulgated rules which are attached hereto and which the Tribal Council approves.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Rules of Conduct for Tribal Court Proceedings promulgated by the Chief Judge of the White Mountain Apache Tribal Court pursuant to Section 16.1 A and B of the Tribal Code.


BE IT FURTHER RESOLVED that the promulgated Court Rules be posted conspicuously in the Tribal Court Room immediately.


The foregoing resolution was on August 13, 1982 duly adopted by a vote of 8 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

R U L E S O F C O N D U C T

of the

WHITE MOUNTAIN APACHE TRIBAL COURT

Whiteriver, Arizona

PURSUANT TO SECTION 16.1, A & B, COURT RULES OF THE TRIBAL CODE as approved by the Tribal Council; those persons in Court attendance must comply with the following Court Rules when entering the Court Room. Please conduct yourself in a manner which demonstrates respect for the Tribal Court:

While Court is in session the following rules must be obeyed:

- 1) No food or drinks of any kind.
- 2) No chewing gum.
- 3) No smoking or chewing tobacco.
- 4) Remove caps or hats.
- 5) Remove sunglasses (non-prescription).
- 6) No firearms or weapons.
- 7) No joking, talking or laughing.
- 8) No playing or running around.
- 9) No intoxicated person (s) or alcoholic beverages, opened or unopened.
- 10) No uncontrollable child or children (unless they are participants in the Court hearing).
- 11) No outbursts or argumentative speeches (unless addressed by the Presiding Judge to do so; otherwise, restrain and conduct yourself accordingly).
- 12) No cameras, video equipment, television cameras or tape recorders.

Any disobedience of the above Court Rules, ORDERS, or process of a Court of Justice, or a disturbance or interruption of its proceedings, shall be subject for removal from the Court Room. Those in contempt may be arrested or punished by fine or imprisonment, or both, according to Section 18.7 of the Tribal Code.
