



PROPOSED RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe has deemed it necessary to review and revise their budget estimates and assumptions as previously discussed per Resolution No. 82-100; and
- WHEREAS, the Tribal Council through the Finance Committee has identified the necessary reductions in order to produce a 1982-83 balanced tribal budget; and
- WHEREAS, previous budget projections would produce a deficit of \$1,049,000; and
- WHEREAS, the revised budget reflects reduced expenditures and additional income; said reductions to be applied as follows:
- a. Approximately 17% in non-personnel items, and
 - b. A reduction in personnel expenses through a 10% reduction in work hours per pay period for all Central Tribe (01) employees; this reduction to be for all competitive (01) positions (elected officials exempt) and will be without pay; and
- WHEREAS, this resolution shall supersede Council Resolution No. 82-225.
- BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe supports and approves all non-personnel and personnel budget cuts as outlined above.
- BE IT FURTHER RESOLVED that the Tribal Council hereby approves a revised Tribal budget for the fiscal year ending April 30, 1983, as follows:
- Projected operational expenditures \$4,124,992; said expenditures to be covered by tribal funds appropriated and placed on deposit with the treasury of the United States in the amount of \$4,286,279. These funds to be expended in accordance with the items listed in the budget attached hereto and made a part hereof; said budget (and revisions reflected therein) to become effective as of September 18, 1982.
- BE IT FURTHER RESOLVED that the Tribal Treasurer shall make disbursement of the funds appropriated herein and only upon signatures authorized by the properly designated tribal employees and approved by the Tribal Chairman and the Administrative Manager.
- BE IT FURTHER RESOLVED that the budget will be reviewed every thirty (30) days and a report will be made to the Tribal Council concerning expenditures and income.
- BE IT FURTHER RESOLVED that Council Resolution No. 82-225 is hereby rescinded.

The foregoing resolution was on October 19, 1982 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i & k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
