

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council is advised that the present ski rates for tribal-member Apache children is \$7.50 per day, and

WHEREAS, the Tribal Council has received numerous requests that the ski rates for Apache children be reduced because the present price of \$7.50 is prohibitly high and prevents children, especially those from large families, from enjoying and learning the sport of skiing, and

WHEREAS, the Tribal Council believes that it's in the best interest of the White Mountain Apache Tribe to encourage its youth to learn to enjoy the sport of skiing and to become adept at the sport so that more tribal members will become involved with the ski industry and eventually become employed by the Sunrise Ski Park, especially in the area of Ski Instructors and Managers which requires knowledge of skiing, and

WHEREAS, the Tribal Council concludes that the ski rates should be reduced for tribal-member Apache children from the age of one year to eighteen years of age to \$3.00 per day, and

WHEREAS, the Tribal Council is further advised that the fee of \$7.50 was established in order to cover the overhead expenses of the Sunrise Ski area, and


WHEREAS, the Tribal Council is advised that the balance of Youth Recreation monies of land claims presently held by the Bureau of Indian Affairs in the approximate amount of \$6,000.00 is available to make up the difference between the \$3.00 fee and \$7.50 fee necessary for Sunrise to cover its overhead and that said monies should be utilized on a first come, first serve basis reservation-wide for that purpose.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby reduces the ski rates for tribal-member Apache children between the ages of one year to eighteen years from \$7.50 to \$3.00 per day with the balance of the \$7.50 in the amount of \$4.50 to be obtained from the remaining Youth Recreation monies from the land claims presently held by the Bureau of Indian Affairs, Fort Apache Indian Agency.

BE IT FURTHER RESOLVED by the Tribal Council that it directs that this program shall be administered under the auspices of the schools within the exterior boundaries of the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council that the schools participating in this program may contact Councilman Raymond Endfield, Jr., the Business Manager for the Sunrise Ski Area for payment and booking arrangements.


