- WHEREAS, the Tribal Council reviewed the applications recommended for approval by the Committee; and
- WHEREAS, the list of tribal members, with description of specific locations is attached hereto.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the homesite and farmland applications as recommended by the Land Board.


