

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Parent Advisory Board of the Chaghashe Day Care Center has requested (by letter of February 22, 1983) that the White Mountain Apache Tribe assist with matching funds in the operation of the Day Care Center during FY 1983/84; said Tribal funds to provide a 50% match with parent contributions to pay staff salaries (per budget attached), and

WHEREAS, the shortage of Tribal funds requires very careful evaluation of all requests for support of community activities, and

WHEREAS, the Tribal Council recognizes the important service provided by the Day Care Center toward development of the Tribal economy and employment for working mothers.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Day Care Center matching budget in the amount of \$21,560, subject to the following restrictions:


1. That the fee schedule of the Day Care Center be raised by at least 33% from the present level;
2. That delinquent payments from parents for day care services be reduced to zero and/or service denied to participants who have a record of slow payment or non-payment;
3. That the matching funds provided by the Tribe be used only for the payroll budget attached hereto; and
4. That a formal evaluation of the Day Care Center by an accredited evaluation agency be conducted during the current fiscal year and a report of the results be presented to the Tribal Council.
