

RESOLUTION OF THE

FORT APACHE INDIAN RESERVATION

WHEREAS, Councilman Raymus Albert, on behalf of the Carrizo and Cedar Creek Communities, has come before the Tribal Council requesting authority from the Tribal Council to expend monies set aside under the Land Claims Account for Youth Recreation purposes for those two communities, and

WHEREAS, in support of his request on behalf of these two communities, he has prepared a Budget for FY 83/84 in the amount of \$5,300.00 which is attached to this resolution and incorporated by reference, and

WHEREAS, Mr. Albert has explained to the Tribal Council how the requested monies will be expended, for films, recreation supplies, recreation facilities, equipment and special events, and

WHEREAS, the Tribal Council concludes that the monies as budgeted will serve a meritorious purpose and benefit Apache Youth in these two communities.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the communities of Carrizo and Cedar Creek to utilize Land Claims monies in the amount of \$5,300.00 as allocated according to the budget presented by Councilman Raymus Albert which is attached hereto and incorporated by reference.






