RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

Cibecue Day School

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe had by prior Resolution No. 83-197, manifested the intent of the Tribal Council to authorize the Cibecue Community Education Board to contract with the Bureau of Indian Affairs for the total operation of the Cibecue Day School, including but not limited to school operations, school administration, maintenance and operations, food services, all educational facilities, and living quarters; and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe, the governing body of the tribe organized pursuant to Section 16 of the Indian Reorganization Act of 1934, hereby requests the Bureau of Indian Affairs to enter into a contract with the Cibecue Community Education Board for the total operation of the Cibecue Day School, including but not limited to all school operations, school administration, hiring and firing, maintenance and operation, food services, all educational facilities and living quarters as well as appropriate Chapter I and Special Education Programs; and
- WHEREAS, the Cibecue Community Education Board shall be the tribally-chartered administrator of the aforedescribed responsibilities and further will be authorized, by the Tribal Council, to contract for Chapter I Programs and Special Education; and
- WHEREAS, the Tribal Council requests that the Bureau of Indian Affairs contract with the Cibecue Community Education Board for the operation of the Cibecue Day School for an initial contract term of three (3) years; and
- WHEREAS, the Tribal Council hereby authorizes the Cibecue Community Education Board to negotiate the contract and any amendments thereto as well as to execute the contract and any amendments thereof; and
- WHEREAS, the expiration date of the authorities granted by this resolution to the Cibecue Community Education Board shall occur upon the last day of the contract with the Bureau of Indian Affairs for the operation of the Cibecue Day School; and
- WHEREAS, the proposed date for the contract commencement shall be September, 1983, and continue therefrom for a proposed term of three (3) years; and
- WHEREAS, the Tribal Council has been requested by the Cibecue Community Education Board to be issued a charter empowering said School Board as the official Tribal Board of Education for the Cibecue Day School with authorization as the contractor to operate and administer the 638 contract for school operations for the Cibecue Day School; and
- WHEREAS, the Tribal Council grants the request of the School Board of the Cibecue Day School for such a charter, and to be the contractor for the 638 contract with the Bureau of Indian Affairs; and

- WHEREAS, this resolution shall supersede Resolution No. 83-197.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby requests that the Bureau of Indian Affairs enter into a contract with the Cibecue Community Education Board, the duly authorized Board of Education, as the contractor for the operation, administration and maintenance of the Cibecue Day School, to commence September, 1983 with a proposed term of three (3) years.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes the Cibecue Community Education Board to negotiate the contract and any amendments thereto and to execute the contract and any amendments thereof, said authorization to expire upon the expiration date of the contract with the Bureau of Indain Affairs for the operation, administration, and maintenance of the Cibecue Day School.
- BE IT FURTHER RESOLVED by the Tribal Council that the authority granted to the Cibecue Community Education Board is to contract with the Bureau of Indian Affairs pursuant to P.L. 93-638 for the total operation of the Cibecue Day School, including but not limited to, school operations, school administration, maintenance and operation, food services, all educational facilities, hiring and firing of teachers and other school personnel, and management of living quarters as well as contracting for Chapter I and Special Education Programs.
- BE IT FURTHER RESOLVED by the Tribal Council that the Cibecue Community Education Board shall administer this contract and perform all of the operations, maintenance, hiring and firing, faculty recruitment, living quarters, maintenance, and administration of Chapter I and Special Education grants and programs.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby issues a charter to the Cibecue Community Education Board as the official tribal school board for the Cibecue Day School which authorizes said chartered board of education to exercise the functions of a board of education as set forth in its Articles of Incorporation and By-Laws to be attached hereto and made a part hereof, subject to the applicable laws of the White Mountain Apache Tribe as may hereinafter be enacted, for a period of five (5) years from the date hereof unless sooner revoked by authority of law or the White Mountain Apache Tribal Council.
- BE IT FURTHER RESOLVED that the Cibecue Community Education Board shall have the right to appeal, pursuant to 25 CFR §271.81 and 25 CFR §271.82.
- BE IT FURTHER RESOLVED that staffing and cirriculum is to be designated with certification as a goal.
- BE IT FURTHER RESOLVED that this Resolution supersedes Resolution No. 83-197.
