## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Raymus Albert, Chairman of the Tribal Land Board has advised the Tribal Council that tribal members, Mary Walker, Cordelia Larzelere and Basil Malone have been given Board approval for land assignments upon which Home Improvement Program housing will be constructed, and
- WHEREAS, Mr. Albert further advises the Tribal Council that all three members have been granted Home Improvement Program houses, but that they lack a land assignment upon which to construct the houses granted to them, and
- WHEREAS, the site description for the land assignments to Mary Walker, Cordelia Larzelere and Basil Malone are attached to this resolution and incorporated herein, and
- WHEREAS, Mr. Albert advises the Tribal Council that the Tribal Land Board investigated the sites and concluded that the land assignments to the tribal members named above will not create any conflict with present land assignments, and
- WHEREAS, the Tribal Council agrees that the land assignments should be granted to the tribal members above named so that Home Improvement Program homes may be built thereon.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the respective land assignments for Mary Walker, Cordelia Larzelere and Basil Malone according to the site descriptions attached to this resolution.

The foregoing resolution was on January 11, 1984 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




