RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, Ms. Peggy Hancock, Right-of-Way Agent, for the Arizona Department of Transportation has come before the Tribal Council with a request for Tribal Council's permission to dismantle the existing meandering Right-of-Way fence, both right and left, from Mile Post 340.8 to Mile Post 350.4 along State Highway Route 73, and
- WHEREAS, Ms. Hancock advised the Tribal Council that the present meandering fence will be dismantled by the Arizona Department of Transportation and will be replaced by a new fence on both sides between the Mile Posts and that the Arizona Department of Transportation is requesting permission to tie the new fence to existing cattlequards and walk-in gates which may possibly be beyond the State Right-of-Way, and further, that the Arizona Department of Transportation also requests permission to clear brush and trees within the Right-of-Way, both left and right, and along the new fence line to existing cattleguards and walk-in gates as is necessary which may possibly require the Arizona Department of Transportation to clear brush and trees outside the existing Right-of-Way, and
- WHEREAS, the Tribal Council is further advised that this project is known as Arizona Department of Transportation Project No. S-215-908.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants permission to the Arizona Department of Transportation to dismantle the existing meandering fence along the Right-of-Way on Route 73, on both sides of the highway, from Mile Post 340.8 to Mile Post 350.4.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby grants permission to the Arizona Department of Transportation pursuant to Arizona Department of Transportation Project No. S-215-908 to install a new fence along the Right-of-Way which may tie to existing cattleguards and walk-in gates which may possibly be beyond the existing Right-of-Way.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby grants permission to the Arizona department of Transportation to clear brush and trees within the Right-of-Way, both left and right, and along the new fence line to existing cattleguards and walk-in gates as is necessary which may possibly be outside the existing Right-of-Way.

The foregoing resolution was on March 08, 1984 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution a u By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
