RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Whiteriver Police Department (WPD) during the past two fiscal years has submitted capital expenditure requests for a total of fifteen (15) replacement vehicles of which only five (5) have been approved, and
- WHEREAS, the continued deterioration of the Whiteriver Police Department vehicle fleet has significatly degraded the law enforcement capabilities of the Whiteriver Police Department, and
- WHEREAS, the minimum vehicle replacement needs for FY 84/85 require the expenditure of between \$154,508.00 and \$171,281.00, which funds would be expended over a period of several weeks sometime after May 01, 1984; while the manufacturer's marketing schedule requires that vehicle orders be submitted within the March/April period, before final approval of the Tribal FY 1984/85 capital budget, and
- WHEREAS, the urgency of the replacement need is so great that prior Council approval of the capital purchase is necessary.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the commitment for future delivery of fifteen (15) vehicles (per the attached vehicle bid schedule) to be paid from capital funds to be appropriated in the FY 84/85 Tribal Budget.

The foregoing resolution was on March 09, 1984 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i & k) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
