

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, Mr. Ross Susan, a Community Leader from Cedar Creek, has requested assistance from the Tribal Council for the reconstruction of the Cedar Creek Community Building in order to serve that community's needs and to provide additional classroom space for the children of the community due to overcrowding at the Bureau of Indian Affairs School, and

WHEREAS, Mr. Susan advises the Tribal Council that the Cedar Creek Community Building, in its present state, is unfit to house children and that the building must be reconstructed in order to accommodate the children, handicapped children and provide a conducive atmosphere for classroom study and community meetings, and

WHEREAS, Mr. Susan requests Tribal Council approval to reconstruct the Cedar Creek Community Building for the purposes set forth herein and requests further, financial assistance in the form of Revenue Sharing Funds, and

WHEREAS, the Tribal Council agrees with Mr. Susan's request and concludes that the Cedar Creek Community Building should be reconstructed in compliance with all requirements necessary to make it suitable as an additional classroom space for the children in the community, and

WHEREAS, the Tribal Council further concludes that Revenue Sharing Funds in the amount of \$75,000.00 should be allocated for the reconstruction project and that the Tribal Council meeting this date should be considered as the first of the three public meetings or hearings required by the regulations pertaining to Revenue Sharing Funds, and

WHEREAS, the Tribal Council advises Mr. Susan to contact Don Booker, the Tribal Administrative Manager, to insure compliance with the public hearings regulations that must be satisfied prior to the disbursement of Revenue Sharing Funds, and

WHEREAS, the Tribal Council further advises Mr. Susan to contact the Acting Superintendent of the Bureau of Indian Affairs and request assistance for possible Bureau of Indian Affairs funds that could be applied to the project.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby the reconstruction of the Cedar Creek Community Building for the purpose of providing an additional classroom for the children of the community and to serve as a safe building for the needs of the Cedar Creek Community.


BE IT FURTHER RESOLVED by the Tribal Council that it requests Mr. Susan to contact Don Booker, Tribal Administrative Manager, and work through his office to insure that public hearing rules in respect to Revenue Sharing Funds are complied with.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby requests Mr. Susan to contact the Acting Superintendent of the Bureau of Indian Affairs in order to request Bureau of Indian Affairs financial assistance for the reconstruction of the Community Building for the purposes set forth herein.

The foregoing resolution was on May 02, 1984 duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
