

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, the Community Alcohol and substance Abuse Task Force Committee has requested that the Tribal Council designate the week of June 11 thru June 16, 1984 as, "Alcohol Awareness Week", and

WHEREAS, Mr. Keno Kane, Director of the Tribal Residential Treatment Center, acting on behalf of the Community Alcohol and Substance Abuse Task Force Committee, has come before the Tribal Council with a request that Alcohol Awareness Week include two "NO DRINK DAYS" on Wednesday, June 13, and Thursday, June 14, 1984, which would prohibit the sale of alcoholic beverages at the WHITERIVER LIQUOR OUTLET ONLY for those two (2) days and; further, that the Tribal Residential Treatment Center be permitted to enclose flyers with information regarding drinking with all tribal employee checks during that week preceding the designated Alcohol Awareness Week, and

WHEREAS, the Tribal Council is agreeable to the proposal presented by Mr. Kane regarding Alcohol Awareness Week, the two "NO DRINK DAYS" as resolved below and for flyers to be enclosed with tribal employee checks preceding the designated Alcohol Awareness Week.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby adopts the week of June 11 thru June 16, 1984 as Alcohol Awareness Week, and designate Wednesday, June 13, and Thursday, June 14, 1984 as "NO DRINK DAYS" which would prohibit the sale of alcoholic beverages to tribal members and the public from the WHITERIVER LIQUOR OUTLET ONLY, and


BE IT FURTHER RESOLVED that the Tribal Residential Treatment Center shall be authorized to enclose flyers giving information regarding drinking with all tribal employee checks issued the week prior to the designated Alcohol Awareness Week.

BE IT FURTHER RESOLVED by the Tribal Council that it directs the Manager of the Apache Enterprise to close the Whiteriver Liquor Outlet only, on June 13, and 14, 1984; and further instructs the Administrative Office to cooperate with the Tribal Residential Treatment Center Director so that public health flyers can be included with all tribal checks issued the week prior to the designated Alcohol Awareness Week.

BE IT FURTHER RESOLVED by the Tribal Council that in the absence or inability for any reason of the Tribal Chairman to execute this resolution, the Vice-Chairman is hereby directed and authorized to do so.

The foregoing resolution was on May 16, 1984 duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
