



RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

- WHEREAS, the family of Harry Sanchez, a tribal member, who is suffering from kidney failure and who is now confined in a Phoenix Hospital, has come before the Tribal Council with an urgent request for financial assistance to construct an additional bedroom to their present home and also to construct a bathroom with adequate facilities for his kidney condition, and
- WHEREAS, the Tribal Council is advised that their request comes under Category B of the Home Improvement Housing Program and that there are carry over funds for Fiscal Year 1983 in the HIP Program in the amount of \$11,500.00 to construct the additional bedroom and bathroom, and
- WHEREAS, the Tribal Council concludes that the request on behalf of Harry Sanchez should be considered an emergency priority, and
- WHEREAS, the Tribal Council in another emergency case has been requested by the family of Glen Caddo, who are presently forced to live in a car and tent and who are also in dire need of a comfortable shelter for financial assistance to construct an adequate shelter under the HIP Program, and
- WHEREAS, the Tribal Council is advised that Mr. Caddo's request comes within Category D of the HIP Program and that he and his family's needs should be considered as an emergency priority under the HIP Program and can be funded under monies available from HIP carry over monies from Fiscal Year 1983, and
- WHEREAS, the Tribal Council is further advised that Indian Health Service will finance and perform the sewer hookup for the additional bedroom and bathroom for Harry Sanchez and the new home for Glen Caddo and his family.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves under Category B of the HIP Program funds in the amount of \$11,500.00 to construct an additional bedroom and bathroom suitable for Harry Sanchez who is now suffering from a kidney condition, to be paid out of HIP Program carry over funds for Fiscal Year 1983.
- BE IT FURTHER RESOLVED by the Tribal Council that pursuant to Category D of the HIP Program, it hereby approves a new home for Glen Caddo and his family said monies in the amount of \$11,500.00 to be appropriated from HIP Program carry over funds for Fiscal Year 1983.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby declares that the situation for Harry Sanchez and Glen Caddo and his family are emergency situations and requests the HIP Program to consider both situations on that basis as priority items.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby requests the Indian Health Service to perform the necessary utility hookup for the bedroom and bathroom addition to Harry Sanchez's home in Canyon Day and for the home for Glen Caddo and his family.

The foregoing resolution was on May 16, 1984 duly adopted by a vote of 7 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
