## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has received information from various sources that the Assistant Director of the Tribal Recreation Enterprise, Mr. Tommy Amos, has misappropriated and utilized tribal property and Tribal funds; such as, credit cards, motor vehicles, for his own personal use and has illegally destroyed or utilized tribal game in violation of Tribal Laws, and
- WHEREAS, the Tribal Council concludes that there is substantial information to believe, based upon the source of information and charges against Mr. Amos, that 'I. Amos should be immediately suspended pending an investigation of the charges against him by the Recreation Board of Directors, and
- WHEREAS, the Tribal Council concludes that the Tribal Internal Audit Department should assist the Board of Directors of the Recreation Enterprise in their investigation of the charges against Mr. Amos, and
- WHEREAS, pending this investigation, the Tribal Council believes that it is in the best interests of the Tribe for the protection of its resources and Enterprise, that Mr. Amos be suspended immediately without pay, that he be required to turn over all tribal credit cards, keys to motor vehicles, motor vehicles and any and all tribal property in his possession to the Director of the Recreation Enterprise until such time as the investigation is complete.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby suspends Mr. Tommy Amos, Assistant Director of the Recreation Enterprise effective immediately and without pay pending an investigation by the Recreation Enterprise Board of Directors with the assistance of the Tribal Internal Audit Department in respect to the charges that have been made against Mr. Amos.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the General Manager of the Recreation Enterprise to recover. from Mr. Amos, all tribal credit cards, keys to motor vehicles and any and all tribal property in the control or possession of Mr. Amos immediately.
- BE IT FURTHER RESOLVED by the Tribal Council that it directs the Recreation Enterprise Board of Directors and Internal Audit tem to conduct an immediate investigation of the charges against Mr. Amos and upon completion of said investigation to report their findings to the Tribal Council.

The foregoing resolution was on August 17, 1984 duly adopted by a vote of <a href="logoling-norm">10 for and 0 against by the Tribal Council of the White Mountain</a>
Apache Tribe, pursuant to authority vested in it by Article V, Section 1
(i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
