

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

Cystic Fibrosis Fun-a-Thon

- WHEREAS, Councilwoman Judy Dehose advised the Tribal Council that she has been approached by the Cystic Fibrosis Foundation to act as chairperson to raise funds to help in the fight to conquer cystic fibrosis; and
- WHEREAS, cystic fibrosis is the number one inherited killer of young people in this country and the mission of the Cystic Fibrosis Foundation is to find a cure or effective control for this tragic disease; and
- WHEREAS, funds raised in such events help to support research, care, education programs and treatment of cystic fibrosis; and
- WHEREAS, Councilwoman Judy Dehose believes that such a fund raising drive is vital to the health of young people in helping the Cystic Fibrosis Foundation find a cure for this disease and has therefore agreed to chair and has organized a committee for a Fun-a-Thon to raise funds to cystic fibrosis; and
- WHEREAS, said Fun-a-Thon will consist of volunteer entrants taking pledges for 25¢ per mile for each mile the entrant rides any un-motorized object on the approximate 20 mile course set from Hondah to Fort Apache; and
- WHEREAS, the Fun-a-Thon will be held in conjunction with the Pinetop-Lakeside Chamber of Commerce Fall Festival which is in the interest of improving and maintaining community relations between the Pinetop-Lakeside area and the White Mountain Apache Tribe; and
- WHEREAS, The Pinetop-Lakeside Chamber of Commerce has offered their full support and cooperation in this event and welcomes the Tribe's participation in the annual Fall Festival; and

WHEREAS, the Fun-a-Thon is scheduled to take place on September 22, 1984 at 1:00 p.m. and entrants will be asked to participate as a group entry in the Fall Festival Parade at 10:00 a.m. on September 22, 1984; and

WHEREAS, Councilwoman Judy Dehose has asked the Tribal Council and Tribal Departments for their approval, support and cooperation in this event.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves and supports the Cystic Fibrosis Fun-a-Thon chaired by Judy Dehose.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs all Tribal Enterprise managers to offer any support and assistance possible to Ms. Dehose regarding this event.

The foregoing resolution was on 9-05-____, 1984, duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984)
