RESOLUTION OF THE
FORT APACHE INDIAN WHITE MOUNTAIN APACHE TRIBE OF THE
AGENCY FORT APACHE INDIAN RESERVATION
WHITERIVER, ARIZ.

WHEREAS, the town's people of McNary, represented by the McNary/Hondah Community Board have advised the Tribal Council that they are planning a cleanup day for McNary on May 1, 1985 and that in order to have a successful cleanup of the townsite, they are requesting Tribal Council assistance for a dump truck to pick up heavy trash and old branches and remove trash and debris from empty lots where homes have burnt down, and

WHEREAS, the Board also requests permission from the Tribal Council to advise town residents that old junk cars should be removed from their homes and streets in front of their homes because they may be in violation of Tribal Ordinances prohibiting abandoned cars in the streets and unlicensed junk yards, and

WHEREAS, the Tribal Council agrees with the request from the McNary/Hondah Community Board and commends their efforts to clean up the town of McNary and make it a safer, cleaner place to live, and

WHEREAS, the Tribal Council concludes, after some discussion, that Mr. Ray Ivins the Safety Coordinator for the Tribe, who is familiar with the problems of junk cars in the town of McNary and some of the other problems and safety hazards existing in the town, is the proper person to coordinate enforcement of the junk yard and abandoned car ordinances and to arrange for a dump truck to assist the Community Board.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby requests Mr. Ray Ivins, the Tribal Safety Director, to meet with the McNary/Hondah Community Board to coordinate and assist the Community Board in their proposed May Cleanup of the town of McNary.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes the use of the Tribal dump truck to make periodic visits to the town of McNary to assist the town people in the removal of heavy trash.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby requests the Tribal Safety Director to meet with Steve Williams, the Tribal Administrative Manager, in order to locate from either Development Enterprise, the Fort Apache Timber Company, Recreation Enterprise or Apache Enterprise, a dump truck and any other equipment necessary to assist the McNary/Hondah Community Board in their May cleanup.

The foregoing resolution was on April 15, 1985 duly adopted by a vote of 9 for and 0 against by the Tribal Council of the White Mountain Apache Tribe pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and By-Laws of the Tribe, ratified by the Tribe June 27, 1958 and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
