FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Attorney advises the Tribal Council that the Law Enforcement Legal Advisor Contract entered into between the Tribe and Robert Alan Hershey expired on April 30, 1985; and

WHEREAS, paragraph 13 of the Contract provides that the Contract, upon the option of the Tribe, may be renewed for the period May 1, 1985 through April 30, 1986; and

WHEREAS, the Tribal Attorney has pre-budgeted funds for the renewal of the Law Enforcement Legal Advisor Contract; and

WHEREAS, the law enforcement agencies of the Tribe have greatly benefited from the services of Mr. Hershey and wish to continue said services.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Amendment to the Law Enforcement Legal Advisor Contract which is attached to this resolution and incorporated by reference herein.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes the Tribal Chairman or in his absence, the Vice Chairman, to execute the attached Amendment to the Law Enforcement Legal Advisors Contract and submit the same to the Bureau of Indian Affairs.



AMENDMENT TO LAW ENFORCEMENT LEGAL ADVISOR CONTRACT  
BETWEEN  
THE WHITE MOUNTAIN APACHE TRIBE  
AND  
ROBERT ALAN HERSHEY, ATTORNEY AT LAW

This is an Amendment to the Law Enforcement Legal Advisors Contract entered into between the White Mountain Apache Tribe (TRIBE) and Robert Alan Hershey, Attorney at Law (LELA) on May 1, 1984.


1. The period of the Law Enforcement Legal Advisor Contract commenced on May 1, 1984 and terminated on April 30, 1985. Paragraph 13 of said contract provides that the Contract, upon the option of the Tribe, may be renewed for the period May 1, 1985 through April 30, 1986.

2. The TRIBE and LELA have mutually agreed to renew the Law Enforcement Legal Advisor Contract for the period May 1, 1985 through April 30, 1986.

3. All other terms of the Law Enforcement Legal Advisor Contract shall remain in full force and effect for the term of this Amendment.
