



RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribe is dedicated to improving and upgrading social and welfare services to elderly tribal members; and
- WHEREAS, the White Mountain Apache Tribal Elderly Services is the tribal entity charged with improving and upgrading the protection and care for vulnerable elderly tribal members; and
- WHEREAS, the White Mountain Apache Tribal Elderly Services recognizes the specific need for Tribal vulnerable elderly programs; and
- WHEREAS, there is funding currently available for improving targeting of services to the vulnerable elderly under Elderly Services; and
- WHEREAS, the White Mountain Apache Tribal Elderly Services is currently in its fourth year of operation and under the Tribal Programs and has demonstrated its effectiveness to the community; and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is the Tribal Governing Body; and
- WHEREAS, the Tribal Council may authorize the Tribal Chairman to negotiate and execute grants, contracts and amendments thereto.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Tribal Elderly Services to submit a proposal under the Elderly Services Program and affirms its support of said application.
- BE IT FURTHER RESOLVED by the Tribal Council that, if funded, that Elderly Services be the authorized Tribal Agency to administer the Elderly Services funds.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes the Tribal Chairman, and in his absence his authorized representative, to negotiate and execute any documents necessary to carry out this resolution.

The foregoing resolution was on November 7, 1986, duly adopted by a vote of eight for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Abstract Resolution for ELDERLY SERVICES

Funding Source: Department of Health & Human Services
Office of Human Development Services

Specific Grant: Improving Targeting of Services
to the Vulnerable Elderly

Amount of Funding: A maximum of \$200,000 for project/17 months

Grant Submitted: December 15, 1986

Matching Funds: In-kind - a maximum \$50,000

Reason for Funding: To address the problems of the vulnerable elderly on the reservation. This proposal intends to deal specifically with elderly abuse and neglect. The objective will be to set up an inter-agency system of prevention and enforcement of Tribal laws, which will be addressed by the Tribal Code.
