- WHEREAS, the Tribal Council of the White Mountain Apache
 Tribe has recognized the potential of the outdoor
 recreation and tourism industries as major contributors to the White Mountain Apache Tribe's economic
 growth; and
- WHEREAS, the Tribal Overall Economic Development Program (OEDP)
 Committee has listed the outdoor recreation and tourism
 industry as a major priority under the FY86 OEDP Plan;
 and
- WHEREAS, the Tribal Council has determined that in order to capitalize on the economic potential of the outdoor recreation and tourism industry, a comprehensive marketing plan, with specific, measurable short and long range marketing strategies and program objectives must be developed; and
- WHEREAS, the Tribal Council has been informed that the United Indian Development Association (UIDA) headquartered in El Monte, California has the professional capability and expertise to provide technical assistance in the development of strategic marketing planning and implementation programs; and
- WHEREAS, the Tribal Council has reviewed the proposed study to develop a comprehensive outdoor recreation and tourism marketing plan and has determined that in view of the economic significance of outdoor recreation and tourism industry to the overall economic development of the White Mountain Apache Nation that said study should be initiated.
- BE IT RESOLVED by the Tribal Council that it hereby authorizes
 Tribal Chairman Reno Johnson, Sr., to direct and coordinate
 with the OEDP Committee and Mr. Milfred Cosen, Director
 of Business Operations, implementation of the proposed
 Comprehensive Outdoor Recreation and Tourism Marketing
 Plan.
- BE IT FURTHER RESOLVED by the Tribal Council that it hereby authorizes Tribal Chairman Reno Johnson, Sr., to submit a request for technical assistance to the United Indian Development Association (UIDA) for the development of a Comprehensive Outdoor Recreation and Tourism Marketing Plan for the White Mountain Apache Tribe.
