## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the White Mountain Apache Tribe recognizes that the constitution of housing access roads are of a high priority; and
- WHEREAS, the Tribe wishes to grant a gratuitous right-of-way 50 feet in width for a distance of 3.05 miles in length for the completed housing project AZ 16-30 (Southwest and North Diamond Creek east and west of Highway 73) as filed in the Office of the Superintendent of the Fort Apache Agency; Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to grant two gratuitous right-of-ways; one 50 feet in width for a distance of 1.56 miles and one 60 feet in width for a distance of .15 Miles for an access road to H.U.D. Projects AZ 16-40 and 42 and access roads serving the numerous home sites in the Alchesay Flat area, as filed in the Office of the Superintendent of the Fort Apache Agency; Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to grant two gratuitous right-of-ways one 50 feet in width for a distance of 2.56 miles and 60 feet in width for a distance of 3.52 miles respectively for a power line road, and frontage road from Round Top turn-off to Harry Brewer's access road and access roads serving numerous other home sites, as filed in the Office of the Superintendent of the Fort Apache Agency; Whiteriver, Arizona; and
- WHEREAS, the Tribe wishes to grant a gratuitous right-of-way 60 feet in width for a distance of .27 mile for the Lupe Drive access road in Cibecue as filed in the Office of the Superintendent of the Fort Apache Agency; White-river, Arizona.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby acknowledges the priority of constructing access roads to the housing of its members.
- BE IT FURTHER RESOLVED that the Tribal Council hereby grants to the Bureau of Indian Affairs the gratuitous rightsof-way as referenced above and as recorded on file in the Office of the Superintendent of the Fort Apache Agency; Whiteriver Arizona;

NOW THEREFORE BE IT RESOLVED by the White Mountain Apache Tribal Council that it hereby requests that 11.11 miles of streets be added to the Bureau of Indian Affairs Reservation Road System and grants the Bureau of Indian Affairs and any contractors with the Bureau of Indian Affairs the right to enter upon Tribal lands for the purpose of surveys, environmental, archaelogical, and soil investigations, and any other activities for the purpose of developing, planning, constructing, designing, and maintaining said highway projects.

The foregoing resolution was on September 17, 1987, duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (f) & (g) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
