

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, the White Mountain Apache Tribal Council is the governing body of the White Mountain Apache Tribe pursuant to Article IV, Section 1 of the Constitution of the White Mountain Apache Tribe; and

WHEREAS, the White Mountain Apache Tribal Constitution at Article V, Section 1 authorizes the Tribal Council to appoint subordinate committees to act in matters determined to be in the best interest of the tribe; and

WHEREAS, the White Mountain Apache Tribal Council has been informed by the Labor Relations Director that there is a need to create a White Mountain Apache Apprenticeship Committee in order to exercise delegated authority and responsibilities in the establishment and efficient implementation of an apprenticeship and training program for the benefit of White Mountain Apache tribal members; and

WHEREAS, the Tribal Council has been presented with the following list of names of individuals proposed to comprise the membership of said apprenticeship committee:

1. Mr. Victor Velasquez, Housing Authority Director
2. Mr. Rod Harvey, NPC Coordinator
3. Mr. Eddie Hall, Data Processing Manager
4. Ms. Marjorie Quade, JTPA Director
5. Mr. Ramon Riley, Labor Relations Director

WHEREAS, the Tribal Council concurs with the Labor Relations Department that the creation of an apprenticeship committee is in the best interest of the Tribe.


THEREFORE BE IT RESOLVED that the Tribal Council hereby establishes the White Mountain Apache Apprenticeship Committee for the purpose of acting on behalf of the White Mountain Apache Tribal Council, in establishing an apprenticeship program and in developing rules, regulations and standards of apprenticeship and training for the benefit of White Mountain Apache tribal members.


BE IT FURTHER RESOLVED that the following individuals are appointed members of the White Mountain Apprenticeship Committee:
