- WHEREAS, Pinetop Logging is presently holding over and as a holdover tenant on the property of the White Mountain Apache Tribe, Pinetop Logging now owes the White Mountain Apache Tribe rental amounts from July 1988 to date; and
- WHEREAS, the Chairman of the White Mountain Apache Tribe has taken appropriate steps through his executive offices to recover past rentals due from Pinetop Logging.
- THEREFORE, BE IT RESOLVED that the Tribal Council of the White Mountain Apache Tribe hereby supports the Chairman of the White Mountain Apache Tribe and the efforts being made through his executive offices to collect past rentals due from Pinetop Logging.
