- WHEREAS, the Tribal Council of the White Mountain Apache Tribe desires that Ms. Quay as Princess represents the White Mountain Apache Tribe at various functions and events and deems it in the best interests of the White Mountain Apache Tribe that such appropriate public relations be conducted.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that a fund is set up in the amount of \$600.00 and that amount is hereby appropriated for the purpose of defraying the travel costs and expenses of Farlene Quay, Miss White Mountain Apache Princess.

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe is the governing body of the White Mountain Apache Tribe; and
- WHEREAS, the Cibecue Community School Board desires to include grades nine and ten in 1989-1990, and grades eleven and twelve in 1990-1991; and
- WHEREAS, the Cibecue Community School Board, Inc. desires to contract for these programs on a multi-year basis; and
- WHEREAS, the Cibecue Community School Board and the Tribal Indian Education Committee have worked together in the planning and jointly support and recommend the high school expansion.
- THEREFORE BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Cibecue Community School Board is hereby authorized to plan, develop, negotiate, and implement a high school at Cibecue pursuant to Resolution No. 07-87-213 which has empowered the Cibecue Community Education Board, Inc. to contract all or parts of the total operation of the Cibecue Community School.
