BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that Fort Apache Timber Company continue to be charged at those rates made effective May 1, 1988 by Tribal Resolution No. 05-88-152.

The foregoing resolution was on September 20, 1989, duly adopted by a vote of SIX for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).





- WHEREAS, the Bureau of Indian Affairs, after considering to determination of an equitable stumpage rate, recommends that Fort Apache Timber Company be charged effective May 1, 1988, at appraised rates that a less than those currently in effect; and
- WHEREAS, the Tribal Council recognizes a need to charge FATCO at stumpage rates that are higher than those currently
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that Fort Apache Timber Company be charged, effective May 1, 1988, the following stumpage rates:
