RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council wishes to express its non-partisan appreciation to outgoing Tribal Chairman Reno Johnson, Sr., for his four (4) years of service to the White Mountain Apache Tribe as Chairman of the Tribal Council and four (4) years service as Vice Chairman as well as eight (8) years service as Councilman from District IV, Canyon Day; and
- WHEREAS, during his term as Chairman, Mr. Johnson accomplished many long lasting achievements for the White Mountain Apache Tribe such as improvements to the Sunrise Ski Area, improvements to the Fort Apache Timber Company, improvements to the Whiteriver Shopping Center, Cibecue Commercial Center, community convenience stores, housing in every community, water and sewer improvements throughout the reservation communities and has zealously defended the tribal homeland, tribal water rights and other natural resources; and
- WHEREAS, having occupied the Tribal Chairman's Office for the past four (4) years, the Tribal Council concludes it is fitting and proper that the Chairman's desk and office furnishings which he used during his term be retired and presented to him together with the 1986 cadillac which he drove as the Chairman's car and these items should be presented to Chairman Johnson as an irrevocable gift in honor of his many years of service to the White Mountain Apache Tribe; and
- WHEREAS, the Tribal Council wishes to express its deep appreciation to Chairman Johnson.
- THEREFORE BE IT RESOLVED by the Tribal Council that in recognition of Mr. Johnson's longstanding service to the White Moun-

tain Apache Tribe that he is hereby presented an irrevocable gift of the Chairman's desk he used during his term in office and the 1986 cadillac he used during his term, as irrevocable gifts.

The foregoing resolution was on April 12, 1990, 1990, duly adopted by a vote of <u>SIX</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Consti- tution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
