

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the Hondah "B" Logging Unit is included in the five year timber program; and
- WHEREAS, the sale contract has been prepared without a formal appraisal; and
- WHEREAS, a formal appraisal will be prepared annually during the Fort Apache Timber Company reappraisal; and
- WHEREAS, the Hondah "B" Logging Unit is in the North Fork Timber Management Block and is part of the annual allowable cut; and
- WHEREAS, the Hondah "B" Timber Sale includes three road construction and reconstruction projects totalling .7 miles as follows:

| Road #1 | .2 mile | to reconstruct old road |
| Road #2 | .5 mile | to reduce skidding cost |
| Road #3 | 200 feet | to reduce haul cost |
- WHEREAS, these road proposals have been reviewed by the Inter-disciplinary Team; and
- WHEREAS, the Tribal Council concludes that the Hondah "B" Sale is necessary for the financial survival of the Tribe and for FATCO's continued operation.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Hondah "B" Logging Unit, including the above-mentioned 3 road projects, as presented in the proposed contract for the sale of timber, and subject to minor changes and administrative adjustments by the Approving Officer, be sold to the Fort Apache Timber Company as described below:


BE IT FURTHER RESOLVED that the Chairman of the Tribal Council or his representative is authorized to execute the contract and related documents necessary to administer the sale of timber for and on behalf of the White Mountain Apache Tribe.

BE IT FURTHER RESOLVED that deductions not to exceed thirteen percent (13%) of the gross receipts received from the Purchaser, will be accrued in the Road Suspense Account. This accrual will continue until the Road Suspense Account is funded to the extent required to provide the road construction fund reserve authorized by the Tribe.

The foregoing resolution was on August 1, 1990, duly adopted by a vote of six for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
