RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

- WHEREAS, the student association of Alchesay High School petitioned the Tribal Council to close the Apache Liquor Store in December of 1990; and
- WHEREAS, the Tribal Council enacted a resolution closing the Liquor Store for a period of thirty (30) days during which time financial and social consequences of said closure could be reviewed; and
- WHEREAS, thirty (30) days has transpired and the student association and Tribal Council have met this date to discuss a compromise solution which would allow the Apache Liquor Store to remain open during certain hours during days which would not interfere or cause embarrassment to the high school student body until such time as the Liquor Store could be moved to a permanent new location; and
- WHEREAS, the Tribal Council has discussed in detail the recreational needs of students including reopening the swimming pool and movie theatres at the Commercial Center and in Cibecue and converting the Liquor Store into a recreation center for students after the Liquor Store business has been moved to a different location;
- WHEREAS, the student association has no objection to the Apache Liquor Store being opened Friday, Saturday and Sunday provided that in the event there is a weekend activity the student association president will contact the Tribal Chairman's Office and so advise that the Liquor Store hours can be adjusted accordingly; and
- WHEREAS, the Tribal Council with the concurrence of the student association have agreed as set forth herein.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that the Apache Liquor Store shall remain closed Monday through Thursday but may be opened during normal business hours Friday,

Saturday and Sunday, provided that in the event that a high school activity on a weekend conflicts with the Liquor Store hours, the student association president shall so notify Tribal Chairman Ronnie Lupe so that alternative hours for the liquor store may be arranged.

- BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the managers of the Whiteriver and Cibecue Commercial Centers to take immediate steps to reopen their respective movie theatres in coordination with the Tribal Chairman's Office and for the Whiteriver Commercial Center Manager to obtain estimates of the cost of reopening the swimming pool for recreational use by students.
- BE IT FURTHER RESOLVED by the Tribal Council that after a suitable location has been found for the Apache Liquor Store and the business has been removed from the building it presently occupies, said building shall be converted and used as a recreation center for students.

The foregoing resolution was on <u>January 9, 1991</u>, duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
