A B S T R A C T

- 1. Chairman Lupe informed members of the Tribal Council that Mr. Lahm and Mr. Dieterich have completed their burning study for the Tribe and excused Bureau personnel for the duration of the report.
- Meeting was called to order at 9:30 a.m. with a full quorum present, Councilman Kino Kane offered the opening prayer.
- 3. Erv Kulosa reported that the results of the last 4 months study will probably take all morning and requested such time. He then introduced Mr. John Dieterich who is eminently qualified for studying the effects of burning, who has been a consultant and has also written papers on the subject.
- 4. Mr. Dieterich contract was to study the effects of fire control burning, or prescribed burning, secondly, to review the operational aspect of control burning of the BIA, and finally to provide alternative for fuel treatment.
- 5. Mr. Dieterich's report included the affects of fire on the mortality of trees, natural regeneration, thinning, wildlife, range, soil, water quality and quantity, aesthetics, and air quality. He provided chronology of events of prescribed burning on the Fort Apache Indian Reservation, along with a brief fire history.
- 6. Members of the Tribal Council viewed a video of a prescribed burn area, as filmed by Erv in May, 1990.
- 7. Mr. Dieterich commented to the Tribal Council that the video showed a severely damage condition as a result of a prescribed burn which is unacceptable; but to evaluate the effect of fire on the area, they would need to go back and see this area in about a year.
- 8. Chairman Lupe and Vice Chairman Altaha along with other members of the Tribal Council voiced their disagreement about the report as submitted by Mr. Dieterich. To which Mr. Dieterich responded that he has attempted to provide the effects of fire management the best he could.

- 20. Council member Raymond Endfield commented that he understood the previous resolution directing the Chairman and Mr. Tate to resolve his request for full time council salary had been settled, but apparently hasn't been done, and voiced strong personal opinions.
