- WHEREAS, the necessary documents of relinquishment of headrights were read and signed by Valentino James, Jr. in the presence of a Notary Public on January 24, 1991, and are attached hereto.
- BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the Tribal Relinquishment Request of Valentino James, Jr., and his tribal membership with the White Mountain Apache Tribe is granted relinquished this date.

The foregoing resolution was on April 11, 1991, duly adopted by a vote of nine for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article III, Section 3 of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
