

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

- WHEREAS, the Tribal Council has been approached by students from Alchesay High School who have requested that the Tribal Council recognize a youth organization that they have organized and named the "White Mountain Apache Tribal Youth Council"; and
- WHEREAS, the Tribal Youth Council has distributed to the Tribal Council a proposed Constitution for their organization; and
- WHEREAS, the Youth Council is requesting that the Tribal Council recognize them as the official Tribal Youth Council of the White Mountain Apache Tribe with certain powers and authority to represent the Tribe as good will ambassadors, to act in matters that concern the welfare of youth and to exercise other powers enumerated in their proposed constitution; and
- WHEREAS, the Tribal Council applauds the organizational efforts of the Youth Council and its attempt to draft a constitution to govern its own procedures; and
- WHEREAS, the Tribal Council concludes that the White Mountain Apache Youth Council should be acknowledged and recognized by the Tribal Council; and
- WHEREAS, the statement of purpose of the Youth Council's Constitution includes inter alia, the promotion of leadership qualities, good study habits, self-confidence, cooperation, and good citizenship among White Mountain Apache Youth; and
- WHEREAS, the Tribal Council urges the Youth Council to consult with the Tribal Attorney for assistance in refining the terminology and wording of their proposed constitution, so as not to conflict with the Constitution of the White Mountain Apache Tribe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby acknowledges and commends the White Mountain Apache Tribal Youth Council for its efforts on behalf of all the White Mountain Apache Youth.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby acknowledges formation of the White Mountain Apache Tribal Youth Council.

BE IT FURTHER RESOLVED by the Tribal Council that it hereby requests that the Tribal Youth Council consult with the Tribal Attorney in respect to completion of the Youth Council Constitution so that it does not conflict with the Constitution of the White Mountain Apache Tribe.

The foregoing resolution was on May 01, 1991, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) and (a) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
