WHEREAS, the Tribal Council has reviewed a proposed budget modification for FY 91-92 which is attached and incorporated by reference herein; and

WHEREAS, the Tribal Council concludes that the requested budget modification should be granted in the form attached hereto.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the attached budget modification for FY 91-92.

The foregoing resolution was on July 10, 1991, duly adopted by a vote of seven for and one against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (a) (i) (k) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
