

RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION

WHEREAS, tribal member Donna (Parker) Vigil and Edwin J. Vigil, a non-member have advised the Tribal Council that an opportunity has arisen for them to purchase an existing business on favorable terms outside the reservation; and

WHEREAS, the purchase of the business is contingent upon the ability of Donna (Parker) Vigil and Edwin J. Vigil, a non-member, to acquire the necessary financing to purchase the business for cash and pursuant to an economic analysis which will be completed concerning the business; and

WHEREAS, the purchase by Donna (Parker) Vigil and Edwin J. Vigil, a non-member, is not only feasible but is also economically desirable and will provide a needed service to the local reservation and non-reservation communities; and


WHEREAS, Donna (Parker) Vigil and Edwin J. Vigil, a non-member, are in the process of obtaining financing and desire an expression of Tribal Council support for their efforts to develop this existing business as a tribal member owned venture; and

WHEREAS, the Tribal Council is of the opinion that the ownership of local businesses by tribal members are to be encouraged and supported by the Tribe and the Tribal Council is of the opinion that the business venture proposed by Donna (Parker) Vigil and Edwin J. Vigil, a non-member, is in the best interest of the White Mountain Apache Tribe and will contribute to the overall development of the local economy.


