

RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION

WHEREAS, District II Councilmember Slim Quay has presented a petition, attached hereto, from the Carrizo Community, requesting Tribal Council permission to utilize \$500.00 for food for Thanksgiving, and \$1000.00 (\$500.00 for food and \$500.00 for gifts) for Christmas from the Carrizo Community Land Claim Fund; and

WHEREAS, the Tribal Council is advised by the Bureau of Indian Affairs that monies should be utilized for recreational purposes as required by settlement documents for 22-D, the Tribe's land claims case; and

WHEREAS, the Tribal Council concludes that authorization should be granted to the Carrizo Community to utilize \$500.00 for the purchase of food for Thanksgiving, \$500.00 for Christmas gifts, and \$500.00 for food for Christmas, from the land claim fund for the Carrizo Community, but advises the community that recreational activities should be incorporated on these two dates in order to comply with the distribution requirements of 22-D, the Land Claims settlement.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Carrizo Community to utilize \$500.00 for Thanksgiving for the purchase of food, \$500.00 for the purchase of food for Christmas, and an additional \$500.00 for the purchase of Christmas gifts from the Carrizo Land Claim fund.

BE IT FURTHER RESOLVED by the Tribal Council that it directs and advises the Carrizo Community to integrate recreational activities on Thanksgiving and Christmas in order to comply with the distribution requirements of the 22-D Settlement.

The foregoing resolution was on November 08, 1991, duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
