

RESOLUTION OF THE
 WHITE MOUNTAIN APACHE TRIBE OF THE
 FORT APACHE INDIAN RESERVATION

WHEREAS, the Tribal Council has traditionally purchased Christmas Candy with General Tribal Land Claims funds for distribution in each District on the Fort Apache Indian Reservation; and

WHEREAS, it is recommended to the Tribal Council that the 1991 Christmas Candy Distribution be made as follows:

WHEREAS, the total cost of 10,700 sacks of Christmas Candy will be paid for by General Tribal Land Claim Funds; and


WHEREAS, it is recommended that the White Mountain Apache Youth Council coordinate the distribution of the Christmas Candy for each district.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the use of General Tribal Land Claim Funds for the purchase of 10,700 sacks.

BE IT FURTHER RESOLVED by the Tribal Council that the White Mountain Apache Youth Council is hereby directed to coordinate the distribution of the Christmas Candy in accordance with this resolution.

The foregoing resolution was on December 05, 1991, duly adopted by a vote of seven for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article V, Section 1 (i) of the Amended Constitution and Bylaws of the Tribe, ratified by the Tribe June 27, 1958, and approved by the Secretary of the Interior on May 29, 1958, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Signatures of the members of the Tribal Council represent their approval of Tribal Resolution No. 12-91-333.
